## **BYD partners with Chandra Asri to roll-out its largest fleet of electrical forklifts in Indonesia**

*This order marks the largest electric forklift commitment for BYD to date in Indonesia*

*The electric vehicles from this order will help to materially reduce fossil-fuel consumption and cut emissions*

Jakarta, Indonesia, 8 February 2021 - PT Chandra Asri Petrochemical Tbk (Chandra Asri) has partnered with BYD, the global leading manufacturer of electric automobiles, to roll out 53 units of pure electric forklifts, which is Indonesia's largest electric forklift fleets to date supplied by BYD. The purchases initiated in 2020 have now been fully completed.

As a world-leading new energy company, BYD seeks to implement green technologies, and to embed world-class safety and environmental standards. In 2012, BYD debuted the world's first mass-produced lithium iron phosphate battery forklifts.

The new e-forklift fleet that is powered by lithium batteries underpins Chandra Asri's focus on Sustainability, to build a sustainable transportation system, save operational costs and improve its ability to tackle climate change. Each year, the fleet will reduce 69,445 kg of liquified petroleum gas (LPG), save 165,360 liters of diesel (solar), cut 446,472 metric kilograms of carbon dioxide, and eliminate nitrogen oxide exhaust
