## **Chandra Asri Wins 2021 Green PROPER from the Ministry of Environment and Forestry**

**Jakarta, 28 December 2021** - The largest integrated petrochemical company in Indonesia, PT Chandra Asri Petrochemical Tbk (Chandra Asri) awarded Green PROPER (Company Performance Rating Assessment Program in Environmental Management) for both of its plants in Puloampel and Ciwandan. The annual award from the Ministry of Environment and Forestry (KLHK) was presented online by Vice President K.H. Ma'ruf Amin and Minister of Environment and Forestry Siti Nurbaya Bakar live from the Vice-Presidential Palace in Jakarta.

**Chandra Asri's Director of Human Resources and Corporate Affairs, Suryandi** said that this award was the result of the hard work of all Chandra Asri employees in carrying out the Company's commitment to environmental management and its contribution to community development.

In community empowerment, Chandra Asri focused on improving the quality of life of the community around the operational area, one of which is through the Infrastructure Improvement and Community Empowerment program in Cisiram Village. Apart from renovating houses to make them fit for habitation, Chandra Asri also built public facilities and provided training in woven bamboo crafts as a provision in developing the beneficiaries' businesses, most of whom are craftsmen.

In environmental management, Chandra Asri made serious efforts to reduce the impact of climate change through the shift to renewable energy by installing solar panels, optimizing the use of steam, rejuvenating equipment with has higher efficiency and also increasing the efficiency of energy used in the production process. In addition, the Company also minimizes hazardous waste generated by implementing the 4R principles throughout the business chain.

Chandra Asri continues to innovate and invest to reduce environmental impact in line with the Company's commitment to implementing SDG's. The Company has also operated an Enclosed Ground Flare (EGF) which was built in its petrochemical complex in Cilegon, Banten with an investment of US\$14 million. This EGF is a smokeless flare which is a combustion processing technology using a closed flaring method without heat and air radiation (noise).

Therefore, in the last four years Chandra Asri has always managed to win the PROPER award from the Ministry of Environment and Forestry. In 2018, Chandra Asri won the Green PROPER for the Puloampel site. In 2019 Chandra Asri won Green PROPER for the Puloampel site and Blue PROPER for the Ciwandan site, while in 2020 the Company won the Blue PROPER for both sites. In 2021, Chandra Asri closed the year with the achievement of Green PROPER also for both sites.
